Pursuant to Section 620 of the New York State Banking Law, the undersigned

(the "Claimant") does hereby present a claim (the "Claim") arising out of a transaction with one

of the New York Agencies (each an "Agency") of Jugobanka A.D., Beograd ("Jugobanka") or

Beogradska Banka A.D., Beograd ("Beogradska Banka") (each a "Parent Bank"), as follows:
